

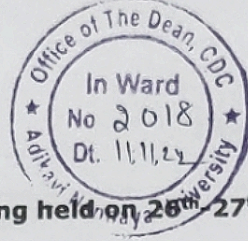

Subject:- Decision of SRC 414th meeting held on 26th-27th September 2022.


Sir/Madam,
