
In continuation of earlier circulars under the references cited above, it is proposed to consider the promotion/award of next higher grade of the university teachers, whose eligibility falls on or before **31.07.20** under Career Advancement Scheme in terms of the Govt. Orders and UGC guidelines issued from time to time. Therefore, applications from the Assistant Professors/Associate Professors who are eligible for the following next higher grade/promotion, as the case may be, are called for in the prescribed proforma and supporting documents etc., **in quadruplicate through proper channel** to the Dean, Academic Affairs along with soft copy on or before **26.06.2020**, consideration as per rules. The already applied members may also submit their fresh applications, if they have any upgraded credentials.

The teachers are requested to refer to the G.O.Ms.No.38, Higher Education (UE.II) Department, dated 23.06.2016, UGC-Regulations on minimum qualifications for appointment of teachers and other academic staff in Universities and Colleges and measures for the maintenance of standards in Higher Education - 2010 and subsequent amendments (www.ugc.ac.in).

As per the section 6.3.10 of GO MS No 14, dated 13.02.19 of Higher Education (UE) department, Govt of AP, "The criteria for promotions under CAS laid down under these regulations shall be effective from the date of notification of these regulations. However, to avoid hardship to those faculty members who have already qualified or are likely to qualify shortly under the existing regulations, a choice may be given to them, for being considered for promotions under the existing regulations". This option can be exercised only within three years from the date of notification of these regulations. Hence, the candidates shall give their choice of CAS Regulations as per UGC 2010 regulations and subsequent amendments or as per UGC regulations 2018 as applicable by submitting the **option form** available in the website.

The University will not process the applications of those who do not fulfill the required eligibility criteria as prescribed in various Govt. Orders/UGC guidelines/clarifications/amendments issued for the purpose from time to time.
