ORDER:

Government have constituted a High Power Committee to examine the feasibility of starting New State Universities in the State and the said Committee recommended for setting of three State New Universities. Accordingly Government have accepted the recommendations and a Bill has been introduced in the last session of the Andhra Pradesh Legislative Assembly to amend the existing University Act and the same has been passed which has become an Act No. 28 of 2006. The Act came into force on the 9th March 2006.

2. In the reference 2nd read above, The Chairman, Andhra Pradesh State Council of Higher Education, has stated that the Adikavi Nannaya University, Rajahmundry one of the newly established three Universities is expected to start functioning with effect from the Academic year 2006-07 i.e. July 2006 and identified certain programme of Study to be taken up from the Academic year and furnished the details of the required Teaching Staff, supporting Staff and requested for issue of orders sanctioning these posts.

3. After careful examination of the matter, Government hereby accord sanction for creation of Teaching and Non-Teaching posts and permitted to outsource certain services for Adikavi Nannaya University, Rajahmundry as detailed in the Annexure to this order.

4. The H.E. (UE.II) Deptt. is requested to take necessary action in the matter.





ORDER:-

The Government of Andhra Pradesh has constituted a high power committee to rationalize teaching staff in Universities in the State vide G.O. 1st read above. The said Committee has submitted its report to the Government vide reference 2nd read above. The Government has sent the recommendations of the Committee to the respective Universities to place the report before the Executive Council and Academic Senate of the University for their recommendations vide reference 3rd read above.

2. The Executive Council of Adikavi Nannayya University, Rajamahendravaram, has approved the recommendations of the rationalization committee in respect of their University in terms of Section 19 of the A.P. Universities Act, 1991 vide reference 5th read above.

3. After careful examination of the matter, Government in accepting the said recommendations of the University and the High Power Committee, hereby rescind the orders issued in the G.O.4th read above as to filling-up of teaching posts in Universities with respect to unfilled sanctioned/vacant teaching posts including unfilled advertised and hereby accord permission for filling-up of teaching posts through direct recruitment subject to condition that the teaching posts for which permission for direct recruitment is being accorded or converted/ downgraded are strictly within and as approved in the recommendations of the High Power Committee, as abstracted below.

O R D E R:

In reference 1st & 2nd read above, the Registrar, Adikavi Nannaya University, Rajamahendravaram has informed that as per NCTE (National Council for Teacher Education) norms 2014 (Section-5 of Norms and standards for bachelor of Education programme leading to the Bachelor of Education (B.Ed) degree and (Section -6 of Norms and Standards for master of education programme leading to Master of Education (M.Ed) Degree) there shall be a permanent sanctioned post of Principal to run College of Education and submitted that University having University College of Education with B.Ed and M.P.Ed Courses approved by the NCTE and University is running these courses under college of education with a temporary arrangement of hiring a qualified candidate as Principal on Ad-hoc basis until regular post is sanctioned by the Government and filled and also University has applied to the NCTE for approval to start M.Ed course. The Vice-Chancellor, Adikavi Nannaya University in his letter 3rd read above has requested to intervene and direct the Andhra University to transfer affiliation of Professional colleges (Pharmacy & Engineering) & PG centers in East & West Godavari Districts to Adikavi Nannaya University and the University is having all the required facilities for effective monitoring of the affiliated colleges under its jurisdiction.

5. Government after careful examination of the matter in detailed and in exercise of the powers conferred in section 6 of the A.P. Universities Act, 1991 (Act 4 of 1991) as amended in Act No.19 of 1993, hereby transfer affiliation of Professional Colleges (Pharmacy & Engineering) and P.G.
