It is to inform that this office is in the process of expanding its National Seismological Network. As part of this endeavour, a new permanent seismological observatory is proposed at Rajahmundry. Considering the sensitive and costly nature of the equipment, it would be preferable if the accommodation is located within the University complex with watch and ward facility. The proposed observatory is going to be un-manned and will be equipped with state-of-the-art earthquake recording instruments with VSAT communication facilities. The recorded data from the observatory shall be transferred continuously through VSAT terminal to this office Operational Centre located at New Delhi for monitoring of earthquake activity in the country.

Based on our previous interaction and your kind willingness to help us, it is requested to allot one room accommodation (size of the room at least 12ft x 14ft) in the University Campus. The accommodation to be allotted, must be located in the ground floor with electricity supply. It should NOT be close to the railway track, busy road, play ground, and high-tension electric wires.

Since the observatory is of national importance for monitoring of earthquake activity, I request you to kindly accord highest priority.

On hearing from you, we will depute a team to examine the technical feasibility of the accommodation/site and to initiate civil and electrical site preparation works, if the site is found to be technically suitable.
