In the above position the A.P State Council of Higher Education requested the Government to issue Revised Appendix to G.O.Ms.No.14, H.E [UE] Department, dt.20-02-2010 by withdrawing the existing one.
- 3. In the above backdrop and after careful examination of the matter, the Government hereby order for implementation of U.G.C Regulations 2010 issued vide No. F.3-1/2009, dated.30.06.2010 and substitute the existing Appendix to G.O.Ms.No.14, H.E [UE] Department, dated.20-02-2010 with the Revised Appendix appended herewith. The revised appendix shall be effective from 30<sup>th</sup> June, 2010.

### Policy of Women Empowerment, Development and Grievances Cell

Women Empowerment, Development and Grievances Cell, also called Women Cell, was constituted in Adikavi Nannaya University with the motto "self-empowered mind", aiming at intellectual and social development of the female students, the female faculty and the staff in the University. It was constituted in the year 2010, vide proceedings, data number, ANU/TS/Women Cell/2010, 22/10/2010 in accordance with the mandate that it shall be the duty of the employer to prevent or deter the commission of acts of sexual harassment and take all steps required to redress such grievances by providing the procedures for the resolution, settlement or prosecution of acts of sexual harassment.

#### Constitution

Women Empowerment, Development and Grievances Cell shall be constituted with representatives from faculty members, administrative head, police, lawyers, activists and students. It shall be constituted in the following structure:

The Executive Body comprises Coordinator, Secretary, Joint Secretary and Treasurer. The tenure of the General Body and Executive Body is 3 years and it shall be reconstituted after the completion of its tenure.

#### **Objectives:**

- To prevent gender discrimination and sexual harassment, by promoting gender amity amongst all employees and students in the University
- To redress grievances related to sexual harassment ensuring support services to the victimized
- To recommend appropriate punitive action against the guilty party to the higher authority
- To create awareness about women's rights according to the Constitution of India and Directive Principles of State Policy
- To ensure a conducive environment on the campus where all girls/ women can learn/ work safely with dignity
- To provide platform for women to share their experiences and views regarding their status in the society and motivate one another
- To enable all women in the University to explore their potentials in all aspects
- To give awareness on various acts related to domestic violence, dowry prohibition, indecent representation of women, sexual assault etc.

#### What is Sexual Harassment?

According to the Supreme Court Judgment, sexual harassment means

- (i) "An unwanted conduct with sexual undertones if it occurs or which is persistent and which demeans, humiliates or creates a hostile and intimidating environment or is calculated to induce submission by actual or threatened adverse consequences and includes any one or more or all of the following unwelcome acts or behavior (whether directly or by implications), namely:
  - (a) any other unwelcome, physical, verbal or non-verbal conduct of sexual nature
  - (b) demand or request for sexual favours
  - (c) making sexually coloured remarks
  - (d) physical contact and advances, or
  - (e) showing pornography
- (ii) any one (or more than one or all) of the following circumstances, if it occurs or is present in relation or connected with any behavior that has explicit or implicit sexual undertones:
  - (a) implied or explicit promise of preferential treatment as quid pro quo for sexual favours;
  - (b) implied or explicit threat of detrimental treatment in the conduct of work;
  - (c) implied or explicit threat about the present or future status of the person concerned;
  - (d) creating or intimidating offensive or hostile environment;
  - (e) humiliating treatment likely to affect the health, safety, dignity or physical integrity of the person concerned.

According to the Code of Conduct at Work Place prepared by the National Commission for Women in 1998, sexual harassment includes such unwelcome sexually determined behaviour by any person either individually or in association with other persons or by any person in authority, whether directly or by implications, such as the following:

- Eve Teasing
- Unsavoury remarks
- Jokes causing or likely to cause awkwardness or embarrassment
- Innuendos and taunts
- Gender based insults or sexist remarks
- Unwelcome sexual overtone in any manner such as over telephone (obnoxious telephone calls) and the like
- Touching or brushing against any part of the body and the like
- Displaying pornographic or other offensive or derogatory pictures, cartoons, pamphlets or sayings
- Forcible physical touch or molestation
- Physical confinement against one's will and any other act likely to violate one's privacy

#### Complaint Redressal Procedure

#### Procedure for Lodging a Complaint

- (i) A complaint of gender discrimination/sexual harassment may be lodged with any Member of the Women Empowerment, Development and Grievances Cell or through heads of respective departments/ sections in writing by the complainant within three months from the date of the incident. If there is a series of such incidents the complaint shall be lodged within three months from the date of the last incident.
- (ii) If a written complaint cannot be lodged by the aggrieved woman, the Women Empowerment, Development and Grievances Cell shall render all reasonable assistance to the aggrieved woman for lodging the complaint in writing.
- (iii) Friends, relatives, colleagues, fellow students, psychologist or any other associate of the aggrieved person shall lodge a complaint if the aggrieved person is unable to lodge a complaint due to physical/mental incapacity or death.
- (iv) A written complaint to the Women Empowerment, Development and Grievances Cell may be addressed to the Coordinator of the Cell.
- (v) A written complaint may be lodged by putting in Complaint Box fixed in different blocks of the University.
- (vi) If a written complaint is addressed to the Registrar/ Principal/ Head of the Department/ Warden /any Member of Women Empowerment, Development and Grievances Cell, the complaint shall be forwarded to the Coordinator of the Cell.

#### **Procedure of Inquiry**

- (i) The Member of Women Empowerment, Development and Grievances Cell to whom the complaint has been given, should give moral support and consult the victim immediately.
- (ii) Women Empowerment, Development and Grievances Cell shall send a copy of the complaint received to the respondent (the accused) within 7 days after the receipt of the complaint.
- (iii) The respondent shall reply to the complaint along with the list of documents, and names and addresses within 10 days after the receipt of the copy of the complaint.
- (iv) On receipt of the written complaint, the Women Cell shall initially try to resolve the dispute through formal discussions.
- (v) If the dispute cannot be resolved through formal discussions, an Inquiry Committee shall be constituted by the Vice-Chancellor with Coordinator of Women Empowerment, Development and Grievances Cell and other members as the case maybe preferably within a week. The Inquiry Committee thus set up will consist of members from the concerned department/ section in addition to the Members of Executive Body and members outside the University, if necessary. At least 50% members of this Committee shall be women. The Inquiry Committee will be headed by a lady Professor and will have one external member (preferably a member of NGO).
- (vi) The inquiry has to be completed within 90 days from the receipt of the complaint. The inquiry report with recommendations, if any, has to be submitted within 10 days from the completion to the Coordinator/ Registrar. Copy of the findings/recommendations shall be given to both complainant and respondent.
- (vii) The Executive Authority of the University shall act on the recommendations within a period of 30 days from the receipt of the inquiry report, unless an appeal against the findings is filed within that time by either party.
- (viii) An appeal against the findings/ recommendations of the Women Cell may be filed by either party before the Executive Authority of the University within 30 days from the receipt of report with recommendations/findings
- (ix) The aggrieved party may seek conciliation in order to settle the matter. No monetary settlement should be made as a basis of conciliation. The University shall facilitate a conciliation process through the Women Cell depending on the nature of case, if conciliation is sought. The resolution of the conflict to the full satisfaction to the aggrieved party wherever possible is preferred to purely punitive intervention.
- During the process of inquiry, the complainant shall be protected against the accused. Ensure that victims or witnesses are not victimized/ discriminated against while dealing with the case. For example, if the complainant/aggrieved person is a student and the accused a teacher, the accused will not act as an examiner to this student. If the complainant is a student and the accused his/her supervisor, his/her supervisor

- may be changed. If the complainant and the accused are both employees, either may be temporarily transferred. If the accused is an outsider, he/she may not be allowed to enter the Institute, during this period.
- (xi) The identities of the complainant/ aggrieved party or the witness or the offender shall not be made public or kept in the public domain during the process of inquiry.
- (xii) Protect the safety of the complainant/ the aggrieved person by not divulging the person's identity and provide the mandatory relief by way of sanctioned leave or relaxation of attendance requirement or transfer to another department or supervisor as required during the pendency of the complaint or also provide for the transfer of the offender.
- (xiii) The victim may be referred to a lawyer, doctor and/or a counselor, if necessary.

#### Procedure for Redressal

- (i) If there is a prima facie case against the accused, Women Empowerment, Development and Grievances Cell may recommend immediate suspension of the accused till the person is proved innocent or the issue is settled.
- (ii) Counseling and mediation should be done to resolve the issue depending on the gravity and nature of the issue.
- (iii) In case the accused is found guilty, Women Empowerment, Development and Grievances Cell may recommend appropriate punitive action to be undertaken by the Vice-Chancellor.
- (iv) The victims of sexual harassment should have the option to seek transfer of the perpetrator or her own transfer to another department or section.
- (v) Leave shall be granted to the aggrieved woman with full protection of status and benefits up to a period of three months. Relaxation of attendance requirement
- (vi) If the accused is a teacher/colleague, he shall be restrained from reporting on or evaluating the work/ performance/ tests of the aggrieved person.
- (vii) The accused should be warned to keep a distance from the aggrieved person(s) and if there is any threat to the latter, the entry of the accused to the campus should be restricted.

#### **Punitive Action**

An employee guilty of sexual harassment shall be liable to give a written apology to the victim and any of the following punitive actions:

- (i) Suitable censure/warning
- (ii) Withholding of increments
- (iii) Reduction to lower service, grade or post
- (iv) Compulsory retirement
- (v) Dismissal from service.



- (iii) Withholding/withdrawing scholarship/fellowship/ allowances and access to the University library, auditorium, laboratories and classrooms
- (iv) Suspension/expulsion from the hostel
- (v) Rustication from the University for a certain period as the case demands.
- (vi) Expulsion from the University
- (vii) Denial of readmission if the offence so warrants.
