This Memorandum of Understanding is entered into on this the 28th day of January 2011 between **Oil and Natural Gas Corporation Limited (ONGC)**, a company registered under the Companies Act 1956, having its registered office at Jeevan Bharti Building, Tower-II, 124 Indira Chowk, New Delhi-110001 (hereinafter referred to as ONGC which expression shall unless repugnant to the context include its representatives, successors and permitted assignees) of the **FIRST PART** and

Adikavi Nannaya University, established by an Act No. 28 passed by the Legislative Assembly of Andhra Pradesh in 2006 and is located in Rajahmundry-533105, Andhra Pradesh (hereinafter referred to as Adikavi Nannaya University which expression shall unless repugnant to the context include its representatives, successors and permitted assignees) of the **SECOND PART**.

Whereas the said University has started a 5-year integrated M.S. Petroleum Exploration course in 2008 and requested ONGC to financially support the said course through development of laboratory facility.

Now ONGC has agreed to give a one time grant of Rs 85,00,000 only (Rupees Eighty Five lakh) inclusive of applicable service tax to Adikavi Nannaya University to partly support 5-year integrated M. S. Petroleum Exploration course.

Therefore it is agreed between the parties through this MoU as follows:

1. SCOPE OF MOU

The MoU details the modalities and general terms and conditions as here under for partly supporting the 5-year integrated M.S. Petroleum Exploration course in Adikavi Nannaya University Rajahmundry.

2. SUPPORT TO M. S. PETROLEUM EXPLORATION COURSE

(i) ONGC will give a one time grant of Rs 85,00,000 (Rupees Eighty Five lakh only) inclusive of applicable service tax to Adikavi Nannaya University for purchase of items for Geological Museum and for purchase of major laboratory equipment for Petrological, Sedimentological, Micro-paleontological Laboratory for running the 5-year integrated M.S. programme in Petroleum Exploration.

(ii) The name of Geology Museum and Laboratory will be ONGC Geology Museum and Laboratory.

(iii) ONGC Geology Museum and Laboratory shall continue to be an administrative and academic part of the The School of Earth & Atmospheric Sciences, Adikavi Nannaya University.

3. RESPONSIBILITIES OF ADIKAVI NANNAYA UNIVERSITY

(i) The Adikavi Nannaya University will ensure to efficiently and timely utilize the grant for purchase of items and major laboratory equipment in ONGC Geology Museum and Laboratory.

(ii) The ONGC Geology Museum and Laboratory facilities will primarily be utilized by the students of 5-year integrated M.S. Petroleum Exploration course.

(iii) Adikavi Nannaya University would undertake basic research projects on topics identified by the department in consultation with ONGC on relevant areas at a later stage for which modalities will be framed afterwards separately.


(iv) Adikavi Nannaya University will be wholly responsible for the management of the ONGC Geology Museum and Laboratory and effective and timely utilization of grant.

(v) Adikavi Nannaya University will submit report on the utilization of the ONGC Grant duly audited by a Chartered Accountant to the Basin Manager KG-PG Basin, ONGC, Rajahmundry and Head of Institute-ONGC Academy, Dehradun.

(vi) Adikavi Nannaya University laboratory facility and library may be utilized by officers of ONGC Rajahmundry.

- (vii) Adikavi Nannaya University shall keep ONGC indemnified against any liabilities from accidents to personnel/property of Adikavi Nannaya University, arising out of execution of this MoU.
- (viii) Adikavi Nannaya University will give a written request to ONGC for release of grant after signing of this MoU and the Income Tax exemption certificate.
- (ix) Adikavi Nannaya University will invite and include the Head of Institute KDMIPE, ONGC, Dehradun and the Basin Manager KG-PG Basin, ONGC, Chennai on the Board of Studies of 5-year integrated M.S. Petroleum Exploration Course.
- (x) Adikavi Nannaya University will accommodate ONGC executives for doctoral programs under extramural mode and the wards of employees for graduate / undergraduate courses under sponsored category in the disciplines where provision exists.
- (xi) Adikavi Nannaya University will coordinate and supervise the training course / workshop / conference for the ONGC executives or hydrocarbon industry, if any, planned in the university campus, and university provides infrastructural facilities without charging institutional fees.

4. RESPONSIBILITIES OF ONGC

- (i) ONGC will give one time grant of Rs. 85 lakh only (Rupees Eighty Five Lakh) inclusive of applicable service tax to Adikavi Nannaya University Rajahmundry for purchase of items for Geological Museum and for purchase of major laboratory equipment for Petrological, Sedimentological, Micro-paleontological Laboratory for partly supporting the 5-year integrated M.S. Petroleum Exploration Course.
- (ii) The grant will be released by ONGC to Adikavi Nannaya University after signing of the MoU and receiving a written request from Adikavi Nannaya University for the release of the grant.
- (iii) Conducting one month training to students of M.S. Petroleum Exploration Course during summer vacation (6th semester) and six month project work during 10th semester at KDMIPE as and when requested by the university.

5. FINANCIAL TERMS AND CONDITIONS

ONGC will give one time grant of Rs. 85 lakh only (Rupees Eighty Five Lakh) inclusive of applicable service tax to Adikavi Nannaya University Rajahmundry for purchase of items for Geological Museum and for purchase of major laboratory equipment for Petrological, Sedimentological,

Both parties to this MoU hereby represents warrants and covenants to the other as follows from the date of this MoU that:


- * Each party will have full power and authority to execute, deliver its obligations under this MoU.
- * This MoU has been duly and validly authorized, executed and delivered by it and constitutes a valid binding obligation of it, enforceable against it in accordance with its terms.


8. DISPUTE RESOLUTION

In the event of any dispute or difference between the parties hereto, such dispute or difference shall be resolved amicably by mutual consultation or through the good offices of Basin Manager KG-PG Basin, ONGC, Rajahmundry. In case such resolution is not possible, then the unresolved dispute or difference shall be referred to a committee consisting of two members each from ONGC and the Adikavi Nannaya University with Director (HR) of ONGC as it's head, the decision of the committee shall be binding upon both the parties. Provided, however, any party aggrieved by such decision may make a further reference for setting aside or revision of the decision to the CMD of ONGC whose decision shall bind the parties finally and conclusively.






