

NANNAYACET – 2020 :: 3rd PHASE ADMISSIONS UNDER CONVENER / SPOT / SELF FINANCE QUOTAS INSTRUCTIONS TO CANDIDATES

The 3rd phase counseling for the left over seats in the programs of M.A / M.Com / M.Sc being offered in AKNU Campus Rajamahendravaram, will be conducted at **AKNU Campus, Rajamahendravaram only in the particular dates** mentioned below:

- 05.02.2021 and 06.02.2021 for Seats in ST, SC, BC & EWS categories, based on the Rank / in case of tie in the rank, percentage in the qualifying degree should be taken in to consideration. (Seats left over in any category, will be converted to open category in the evening of 06.02.2021).
- 08.02.2021 and 09.02.2021 for Open Category seats to be filled based on the Rank / in case of tie in the rank, percentage in the qualifying degree should be taken in to consideration.
- 10.02.2021 and 11.02.2021 Spot admissions for the left over seats for CET or Non-CET candidates.
- 12.02.2021 Self Finance seats in Science Courses
- 13.02.2021 Self Finance seats in Arts Courses
- The candidates must report by 9.00AM on the respective dates of counseling with all required original certificates and course fee. Registration will be done between 9am to 11 am only. If the candidate fails to register within the specified time (9 am to 11 am) his / her rank will not be considered for allotting the seats irrespective of merit.
- If the candidate gets admission, seat allotment will be done on the same day and he/she has to pay the total course fee immediately in the cash counter. Otherwise the candidate will lose the seat.
- The candidates must report by the time mentioned in the above schedule on the respective dates of counseling with all required original certificates and course fee.

Certificates to be submitted at the time of the counseling

1. **Counseling fee** of Rs.500/- and Rs.250/- for SC, ST (for fresh candidates only)
2. **Total Course fee** amount in cash for admission (Check the fee structure file)
3. NANNAYA CET - 2020 Rank Card & Hall Ticket.
4. Degree/Provisional Pass Certificate.
5. Consolidated Marks statement of the Qualifying Examination.
6. Transfer and Conduct Certificate from the institution where the candidate last studied. Candidates who have completed /studied already or discontinued and seeking admission to second PG or professional course should submit TC relating to first PG course only.
7. Migration Certificate (for other Universities).
8. Date of Birth Certificate (SSC/Matriculation or equivalent Certificate).

9. Study Certificates for the last seven years or Residence Certificate for preceding seven years of the qualifying examination.
10. Intermediate original certificate.
11. Valid latest Community Certificate issued by the competent authority in case of SC/ST/BC/EBC/Minority candidates.
12. Valid latest income certificate issued by M.R.O./Thasildar or white ration card if fee concession is claimed.
13. 4 recent passport size Photos.
14. Physical fitness certificate from an Asst .Civil Surgeon.
15. One set of Photostat copies of all the above certificates.
16. After verification of the certificates, the candidate will get all his/her Original certificates back except T.C., C.C. and Migration certificate. The receipt of these original certificates shall be given to the candidate.

*** **Note:-** Candidates are requested to note:

1. Due to corona Pandemic Prevailing, **very limited seats are available in the hostels of both Men & Women.**
2. As per G.O.Ms. No. 77 dated 25.12.2020, **there will be no fee reimbursement for PG Courses in any Private Aided / Unaided degree or PG colleges** from the Academic Year 2020-2021. **GO for reference**

ORDER:

1. In the reference 2nd read above, Government have formulated two new schemes viz. (i) "Jagananna Vidya Deevena (RTF)" and (ii) "Jagananna Vasathi Deevena (MTF)".
2. After careful consideration and in partial modification of G.Os under reference 1st and 2nd read above, the Government hereby orders that in case of Post Graduation courses, the (i) "Jagananna Vidya Deevena (RTF)" and (ii) "Jagananna Vasathi Deevena (MTF)" schemes shall be applicable only to the students admitted under Convener quota in the Post Graduate programs/Courses offered by the State funded Universities and Government Degree/PG Colleges in the State of Andhra Pradesh from 2020-21.
3. The Schemes under para (2) above are not applicable in case of Post Graduate programs/courses to the students admitted under convener quota, either regular or self-finance mode, in the Private Aided and Private Unaided Degree/PG Colleges from the academic year 2020-21 fresh admissions.
4. The CEO of APCFSS is directed to make necessary modifications in the software accordingly.
5. The Director of Social Welfare, A.P. shall take necessary action accordingly.
