While referring to the subject and reference cited, I am directed to inform that the Director of Welfare for Differently Abled has requested this Office to send Action Taken Report as regards (i) implementation of reservation of seats for Persons with Disabilities in the educational institutions working under the University jurisdiction and also (ii) the Barrier Free Environment features created and available in the Institutions for easy accessibility of Persons with Disabilities, to submit the same to the Hon'ble Supreme Court.

I am direction to inform that the Universities and Colleges shall implement 3% reservation as per Persons with Disabilities Act 1995 and subsequently increased to 5% in the Rights of Persons with Disabilities Act 2016 and also creation of Barrier Free Environment features such as Barrier Free Environment in campus with mandatory provision of Lifts, ramps, removal obstacles, on campus accommodation to PWDs, providing Braille symbols for Visually impaired, Auditory signals for Hearing Handicapped, modifications in laboratories, library rooms, computer rooms etc., as per Hon'ble Supreme Court judgement. Copy of the Supreme Court judgement in WP (C) No. 292 of 2006 is enclosed herewith for ready reference.

In this background, I am directed to request the Registrars of AP State Universities to incorporate in the Rules on the above aspects for Affiliation of Colleges, if not included, and also send implementation report on each of the aspects mentioned in the above para immediately to email: ddapshce1988@gmail.com so as to compile the information and send to the Government.
