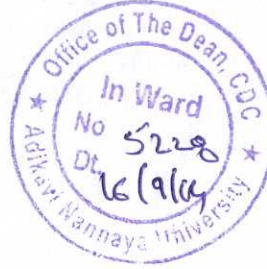

A copy of the reference cited is enclosed herewith.

2. In the reference cited, the Secretary, MHRD has informed Ministry of Human Resource Development has been operating "Central Sector Scheme of Scholarship for College and University students" from the year 2008-09. The said scheme is one of the 60 scholarship schemes on-boarded on National Scholarship Portal. The scheme has been included in the DBT programme of the Government of India and scholarship is being disbursed directly into the bank account of the beneficiaries from 1st January 2013. The scheme is implemented by the State Education Boards/CBSE. In this regard the following actions have been initiated/decided:

- i. All Institutes that do not have valid AISHE codes have been deregistered. A provision has been made for their re-registration after obtaining valid AISHE code.
- ii. Email ids and mobile numbers of all Institutes registered/stored in NSP have been deactivated. State Nodal officers, will verify credentials of the Institute Nodal Officer and reset his/her password through a well-defined procedure, wherein, the Institute Nodal officer will fill up an online form on the Portal and get the printout authenticated in Duplicate with his/her Head of the Institute and submit it to the State Nodal Officer. On verification, State Nodal officer will activate the account of the Institute on the Portal using their login credentials.
- iii. State Nodal officer will retain a copy of duly authenticated online form received from Institute, and return the second copy to the Institute for their respective records. It will be the responsibility of the Institute to retain the copy received from State Nodal Officer and produce it to the appropriate authority on demand.
