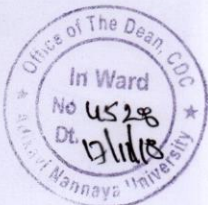

Sir/Madam,

The Government of India and University Grants Commission is continuously monitoring the progress of implementation of reservation Policy for SCs, STs & OBC and Persons with Disabilities in teaching and non-teaching posts as well as admission to all level courses in universities and colleges.

According to UGC Act, 1956, the UGC has to ensure effective implementation of the reservation policy in Universities and institutions receiving aid from the public funds except in Minority Institutions under Article 30(1) of the Constitution. All centrally funded Universities/colleges/Institutions to ensure strict compliance of Government of India orders/rules on the reservation in their institutions. State Universities including its affiliated/constituent colleges and other Institutes functioning within the State can follow the percentage of reservation for SC/ST & OBC as prescribed by the State Government.
